Notes to Sponsor Membership

Sponsor membership is open to firms, organisations or persons engaged in or having an interest in acoustics, and whose support can advance the aims and objectives of the Institute. Proposals for election to the class of Sponsor Member shall come to the Committee's consideration and with the support of a Corporate Member who is acquainted with the work and interests of the applicant. Staffs of the Sponsors would gain better vision and wider exposure by joining HKIOA and take advantages of our events and activities to keep abreast of the acoustics development. The details of Sponsor Member are shown as below:

- Annual subscription of Sponsor Membership is HK\$5,000. The membership is valid only if the subscription has been paid.
- Each applicant can nominate up to 2 staffs joining the activities organized by the Institute with member's privileges and price. The nominated staffs are not necessarily being the member of the Institute. More participation may be allowed depending on the nature of the individual activity.
- The nominated staff can be vacated by other staffs through written notification(s) from the representative of Sponsor Member (firm or organization) annually. The representative could be one of the nominated staffs.
