Environmental impact assessment (EIA) is evolving in response to global challenges. On an international scale EIA is being studied and reviewed; its limitations and opportunities for improvement identified. At the same time, the need for integrated human health, social, economic and environmental assessment is being deliberated. Asia is also facing changes to the EIA process as evidenced by recent judicial review in Hong Kong and greater public scrutiny of EIA projects. But, is Asia keeping pace with new developments in EIA and related environmental assessments? In a rapidly changing sector, how do we make sure that EIA continues to inform and influence decisions in the Asian environment?

The aim of the symposium is to explore the changing focus of EIA, not only in Asia but globally, and identify opportunities to shape EIA for the future.

Health Impact Assessment (HIA)—impacts on health and populations; should we integrate HIA into EIA? Encouraging discussion about challenges, issues and innovative applications.



Climate Change and EIA – how should EIA consider climate change? How are carbon emissions, mitigation and adaptation being considered at the project and strategic level?



Strategic Environmental Assessment (SEA) – how is it being applied across Asia. What can be learnt from international experience?
